Plot schedules reconciled

1 Sheds

Would it be possible to obtain from Gerry a schedule of the allotments with sheds and the date they were erected and how much has been recovered in rent for each shed.

Was any money recovered from tenants to repair the sheds when the vacated their allotments

It was decided that invoices for 2013-14 to be issued as before with the sheds include and any problems regarding shed to be tackled as they arose. There is a need to reconcile the shed to plot numbers the dates they were erected and how much has been collected for each site.

Plot 39 have complained regarding the state of their shed as they are due to take over Plot 37 which has a shed in better condition at this stage it was decided not to charge rent for this shed until the question regarding the future shed policy is resolved.

Note these should be erected at the ends of the Plots so access onto the Plot is not restricted

4 Key deposits

It was agreed this to be reduced to £10 per key for new tenants.

7 Tree lopping

These are required but will have to wait until Funds are available NFA at this time

10 Update on Community Garden Meeting

11 Old age pension criteria

It was confirmed that 65 was the age when plot holders would be eligible for a reduction in their rent

12 Insurance, Health and Safety

The question was raised as to whether the MCC insurance policy also covered the allotments and to what degree.

GB raised the question of whether it was possible to try again to set up an Allotment Association.
